DETERMINATION BY PRIVATE RENTED HOUSING COMMITTEE

Statement relative to Variation of Repairing Standard
Enforcement Order issued by the Private Rented Housing
Committee under Section 25 of the Housing (Scotland) Act 2006
and Certificate of Completion of work issued by the Private
Rented Housing Committee under section 60 of the Housing
(Scotland) Act 2006

Background

1. The Private Rented Housing Committee ('the Committee') had issued a Repairing Standard Enforcement Order ('RSEO') in respect of the Property which required the Landlords:

'To carry out such work as is necessary for the purposes of ensuring that the Property meets the repairing standard and that any damage caused by the carrying out of any work in terms of this Order is made good.

In particular the Private Rented Housing Committee required the Landlords to:-

- (1) Eradicate the dampness in the Living room, Kitchen, Bathroom and Hall and carry out necessary redecoration.
- (2) Repair the leaking water pipe at the wash hand basin in the bathroom.
- 2 On 5th August 2013 the surveyor member of the Committee inspected the property and found that the required works had been satisfactorily completed, with the exception of the redecoration works, which was party completed and which the Landlords confirmed would be completed promptly.
- 3 Thereafter the Committee agreed that a further reinspection to ascertain that the redecoration works had been completed was not required. The Committee agreed to vary the RSEO to revoke the requirement to redecorate. The Committee also agreed that the remaining works required by the RSEO had been completed and the appropriate Certificate of Completion in terms of Section 60 Housing (Scotland) Act 2006 should be issued.

Right of Appeal

4 A landlord or tenant aggrieved by the decision of the Private Rented Housing committee may appeal to the Sheriff by summary application within 21 days of being notified of that decision.

Effect of section 63

Where such an appeal is made, the effect of the decision and of the order is suspended until the appeal is abandoned or finally determined, and where the appeal is abandoned or finally determined by confirming the decision, the decision and the order will be treated as having effect from the day on which the appeal is abandoned or so determined.
