



**Decision with Statement of Reasons of the First-tier Tribunal for Scotland  
(Housing and Property Chamber)**

**Decision (in absence of the Respondent)**

**The First-tier Tribunal for Scotland (Housing and Property Chamber) (“the Tribunal”) determined that an order for payment should be made.**

**Background**

The Applicant sought an order for payment of rental arrears totalling £3,450.00. The Applicant had lodged with the Tribunal Form F. The documents produced were a Tenancy Agreement, a Notice to leave, served on 10 March 2020, together with a notice under s.11 of the Homelessness (Scotland) Act 2003. A copy land certificate was lodged with the Tribunal which showed that the applicant is the heritable proprietor of the Property.

**Case Management Discussion**

A case management discussion took place by telephone conference at 2pm on 23 September 2020. The Applicant’s solicitor wrote to the tribunal advising that he could not attend but provided written submissions. The hearing was delayed until 2.15pm to allow sufficient time for the respondent to participate, but there was no appearance by or on behalf of the Respondent.

The applicant's representative served an up to date statement of arrears of rental. The arrears now total £4,800.00. The applicant asks to amend the sum applied for to £4,800.00 in terms of s13 of the 2017 Procedure Rules. That application is not opposed. The sum applied for is amended to £4,800.00.

### **Findings in Fact**

The Tribunal made the following findings in fact:

1. The Applicant and the Respondent entered into a private residential tenancy Agreement for the Property dated 1 May 2019. The respondent took entry to the property on the same day.
2. The rent in terms of the Tenancy Agreement was £675 per month.
3. The applicant served a notice to leave on 10 March 2020 because he wanted to sell the property. The respondent should have left the property on 3 June 2020 but did not. Instead he remained in the property and did not pay rental.
4. The respondent was regularly late in payments of rental. The respondent has not paid any rental since 1 April 2020. At the date of application there were arrears of rental of £3,450, which is more than 3 months' rent. At today's date the rent arrears total £4,800.
5. On 10 March 2020 the applicant served a notice to leave on the respondent in terms of s.50 of the Private Housing (Tenancies) (Scotland) Act 2016. On 22 July 2020, the applicant submitted an application to the tribunal.
6. The respondent offers no resistance to this application. Notice of the time, date and place of this hearing was served on the Respondent by sheriff officers on 27 August 2020

### **Reasons for the Decision**

The Tribunal determined to make an Order for payment of £4,800. Rent was lawfully due in terms of clause 8 of the Tenancy Agreement at the rate of £675 per month. The respondent has not paid any rent since 1 April 2020. There are now arrears of rental totalling £4,800.00.

### **Decision**

For the foregoing reasons, the Tribunal determined to make an Order for payment.

## **Right of Appeal**

**In terms of Section 46 of the Tribunal (Scotland) Act 2014, a party aggrieved by the decision of the Tribunal may appeal to the Upper Tribunal for Scotland on a point of law only. Before an appeal can be made to the Upper Tribunal, the party must first seek permission to appeal from the First-tier Tribunal. That party must seek permission to appeal within 30 days of the date the decision was sent to them.**
