Decision with Statement of Reasons of the First-tier Tribunal for Scotland (Housing and Property Chamber) under Section 18 of the Housing (Scotland) Act 1988

Decision (in absence of the Respondent)

The First-tier Tribunal for Scotland (Housing and Property Chamber) ("the Tribunal") determined that the application should be dismissed.

Background

The Applicant submitted an application seeking an order to evict the Respondent from the property at 74 Stafford Road, Greenock, PA16 0TE. The Tribunal intimated the application to the Respondent on10th March 2018 and advised her of the date, time and place of today's case management discussion. In that letter, the Respondent was advised that any written representations she wished to make should be sent to the Tribunal by 28th March 2018. No written representations were received by the Tribunal. The Respondent was told that she required to attend the case management discussion and was informed that the Tribunal could make a decision today on the application if the Tribunal has sufficient information and considers the procedure to have been fair.

The Case management discussion

The hearing took place in the absence of the Respondent. The Applicant was represented by Mr Slack, Solicitor. He advised that the Respondent has already left the property and the Applicant has recovered possession. In these circumstances, the application for eviction was not insisted upon.

Findings in fact

- The Applicant and Respondent entered into a tenancy agreement dated 29th September 2017. The period of the tenancy was from 29th September 2017 to 29th March 2018. The rent payable was £450 per calendar month, payable in advance.
- 2. The Applicant has already recovered possession of the property.

Reason for Decision

The Tribunal proceeded on the basis of the written documents which were before it. The order is no longer necessary.

Right of Appeal

In terms of Section 46 of the Tribunal (Scotland) Act 2014, a party aggrieved by the decision of the Tribunal may appeal to the Upper Tribunal for Scotland on a point of law only. Before an appeal can be made to the Upper Tribunal, the party must first seek permission to appeal from the First-tier Tribunal. That party must seek permission to appeal within 30 days of the date the decision was sent to them.
