Decision

Reasons

1. On 18 April 2017 the ordinary member who is a qualified surveyor carried out a re-inspection of the property for the purpose of establishing if the work required under the RSEO had been satisfactorily completed.

- 2. Following on the re-inspection the ordinary member prepared a report dated 19 April 2017 which is attached hereto as a Schedule. The report noted that the work required had been completed and that there was no outstanding requirement.
- 3. Accordingly the tribunal determined that the landlord had complied with the RSEO and determined to revoke same in terms of Minute of Completion of this date.

In terms of section 46 of the Tribunals (Scotland) Act 2014, a party aggrieved by the decision of the tribunal may appeal to the Upper Tribunal for Scotland on a point of law only. Before an appeal can be made to the Upper Tribunal, the party must first seek leave to appeal from the First-tier tribunal. That party must seek permission to appeal within thirty days of the date when the decision was sent to them.

RSEO – In terms of the RSEO issued on 25th February 2016, the Landlord was required to carry out such work as was necessary to ensure that the house meets the repairing standard and in particular the following specific areas: -

- Liaise with the property factors responsible for management of the development of which the property forms part to ensure that such repairs are carried out as are necessary to the secure door entry system to ensure that two-way communication is available between the flat handset and building entry panel and that the entire secure entry system is in proper working order.
