

Determination by Private Rented Housing Committee

Decision to grant a Certificate of Completion or work under Section 60 of the Housing (Scotland) Act 2006

Re property at: Flat 3/2, 40 Wellmeadow Street, Paisley, PA1 2EG, being the right hand flat on the third floor or top floor of the tenement 40 Wellmeadow Street, Paisley and being the subjects registered in the Land Register of Scotland under Title Number REN97359 ("the Property")

Decision

The Private Rented Housing Committee ("the Committee"), having made such enquiries as it saw fit for the purpose of determining whether the Landlord has complied with the terms of the Repairing Standard Enforcement Order ("RSEO") dated 2 September 2014 in relation to the property concerned, have determined that the Landlord has now complied with the terms of that RSEO and that it is accordingly appropriate to grant a Certificate of Completion.

Statement of facts and reasons

- 1. The Committee issued a RSEO in respect of the property dated 2 September 2014.
- 2. The Surveyor Member of the Committee re-inspected the property on Wednesday 19 November 2014 in order to ascertain whether the work required by the RSEO had been completed. The Surveyor Member of the Committee noted, at the time of the re-inspection, that the guttering at the rear elevation of the property had been renewed. At that time the Surveyor Member further noted that the mould growth on the second floor of the common stairway of the property had not been repaired.
- 3. On 11 December 2014, Messrs Castle Residential, acting as agents for the Landlord, confirmed that the outstanding works to repair the mould growth on the landing of the property had been completed. A copy of the Landlord's comments were made available to the Tenant and the Tenant was asked to confirm whether they were satisfied that the works had been completed. The Tenant failed to respond to that further correspondence. On the 18 March 2015, the agents for the Landlord again confirmed that all repairs which had been required by the RSEO had been completed.

The Tenant has failed to correspond further with the Committee.

4. In all the circumstances of the case and given the correspondence from the Landlord's agents, the Committee are of the view that there is a sufficiency of evidence for which they can be satisfied that all works as required by the RSEO have been completed.

5. The Committee have accordingly now determined that the works required by the RSEO are complete. In the circumstances, the Committee are satisfied that the requirements of the RSEO have been complied with and it is now appropriate to grant a Certificate of Completion.

Right of Appeal

6. A landlord or tenant aggrieved by the decision of the Private Rented Housing committee may appeal to the Sheriff by summary application within 21 days of being notified of that decision.

Effect of section 63

7. Where such an appeal is made, the effect of the decision and of the order is suspended until the appeal is abandoned or finally determined, and where the appeal is abandoned or finally determined by confirming the decision, the decision and the order will be treated as having effect from the day on which the appeal is abandoned or so determined.
