# DETERMINATION BY PRIVATE RENTED HOUSING COMMITTEE Statement relative to Certificate of Completion of work issued by the Private Rented Housing Committee under section 60 of the Housing (Scotland) Act 2006

### NOTICE TO James Carswell residing at 2, Commoncraig Place, Inverkip, PA16 0BE

#### Background

- On 19<sup>th</sup> March 2012 the Private Rented Housing Committee ('the Committee') issued a
  Determination that part of the works required by the Repairing Standard Enforcement Order
  ('RSEO') in respect of the Property had been completed and part of the works were outstanding.
  They required the outstanding works to be completed by 25<sup>th</sup> May 2012.
- 2. The outstanding works were:
  - 2.1 Eradicate the dampness/ water ingress in the living room wall, the flooring underneath the washing machine/sink and dishwasher and the kitchen wall and carry out necessary redecoration.
  - 2.2 Repair and renew the following electrical items and render the said items in proper working order such that they comply with the current electrical standards:-
    - 2.2.1 Repair and relocate the broken main light switch in the downstairs bathroom such that it is located out with the bathroom.
    - 2.2.2 Remove the double socket within the downstairs bathroom.
    - 2.2.3 The light switches in the Property.
    - 2.2.4 The broken double socket and light switch in the back bedroom.
    - 2.2.5 The ceiling light fitment in the front bedroom.
    - 2.2.6 The wiring in the Property.
  - 2.3 Effect repairs to render the WC in the upstairs bathroom in proper working order.
  - 2.4 Repair or replace the boiler to render it in proper working order.
- 3 On 5<sup>th</sup> July 2012 the Committee inspected the property and found as follows:-
  - 3.1 The living room wall had been newly re-plastered and decorated and there was no evidence of dampness remaining. The flooring underneath the washing machine/sink and dishwasher and the kitchen wall had been replaced and there was no evidence of dampness.

- 3.2 The property had been rewired and the defective electrical items had been repaired and rendered in proper working order.
- 3.3 The WC had been repaired and had been rendered in proper working order.
- 3.4 The boiler had been replaced and was in proper working order.
- 4 Thereafter the Committee agreed that the works required by the RSEO had been completed and the appropriate Certificate of Completion in terms of Section 60 Housing (Scotland) Act 2006 should be issued.

#### **Right of Appeal**

5 A landlord or tenant aggrieved by the decision of the Private Rented Housing committee may appeal to the Sheriff by summary application within 21 days of being notified of that decision.

#### Effect of section 63

Where such an appeal is made, the effect of the decision and of the order is suspended until the appeal is abandoned or finally determined, and where the appeal is abandoned or finally determined by confirming the decision, the decision and the order will be treated as having effect from the day on which the appeal is abandoned or so determined.
