# STATEMENT OF DECISION OF THE PRIVATE RENTED HOUSING COMMITTEE UNDER SECTION 60 OF THE HOUSING (SCOTLAND) ACT 2006

## DECISION

The Committee, having considered the terms of the Landlord's Gas Safety Certificate provided to the office of the PRHP on 13 September 2016 determined that the work required by the Repairing Standard Enforcement Order dated 25 July 2016 ("the RSEO") had been completed and resolved to issue a Certificate of Completion of Work.

The decision of the Committee was unanimous.

## Background

The RSEO required the Landlord within 28 days:

To produce a Landlords Gas Safety Certificate issued by a Gas Safe registered engineer confirming that the gas central heating system is in safe working order.

## Reasons for the Decision

The Landlord has produced a Gas Safety Certificate dated 10 August 2016 which confirms that the gas central heating boiler is in satisfactory working order. Accordingly, the works required by the RSEO have been completed.

## Right of Appeal

Section 64 of the Act provides a right of appeal to a landlord or tenant aggrieved by a decision of a private rented housing committee. An appeal may be made to the Sheriff within 21 days of the Landlord or Tenant being informed of the decision.

Where such an appeal is made, the effect of the decision and the order is suspended until the appeal is abandoned or finally determined, and where the appeal is abandoned or finally determined by confirming the decision, the decision and the order will be treated as having effect from the day on which the appeal is abandoned or so determined.
