Decision

The First-tier tribunal for Scotland (Housing and Property Chamber) ("the Tribunal"), having carried out a further inspection of the House determined that the work required by the Repairing Standard Enforcement Order dated 29 September 2016 ("the RSEO") had been completed and resolved to issue a Certificate of Completion of Work.

The decision of the Tribunal Members was unanimous.

Background

The RSEO required the Landlord to complete the following work within 60 days of service of the RSEO:

To repair or replace the double wooden doors in the dining area of the kitchen such that there is present a door or doors which are in sound condition, reasonably weatherproof and reasonably draught proof.

Reasons for the Decision

On 16 December 2016, the Surveyor Member carried out a re-inspection of the Property.

At the re-inspection it was observed that the old double door had been replaced with a new UPVC framed, double glazed, double door. Photographs taken at the re-inspection are produced.

Accordingly, all works required by the RSEO have been completed.

Right of Appeal

A landlord, tenant or third party applicant aggrieved by the decision of the tribunal may seek permission to appeal from the First-tier Tribunal on a point of law only within 30 days of the date the decision was sent to them.

Effect of section 63

Where such an appeal is made, the effect of the decision and of the order is suspended until the appeal is abandoned or finally determined, and where the appeal is abandoned or finally determined by confirming the decision, the decision and the order will be treated as having effect from the day on which the appeal is abandoned or so determined.


