

## STATEMENT OF DECISION OF THE PRIVATE RENTED HOUSING COMMITTEE UNDER SECTION 26(1) OF THE PRIVATE RENTED HOUSING PANEL (APPLICATIONS AND DETERMINATIONS) (SCOTLAND) REGULATIONS 2007

#### DECISION

The Private Rented Housing Committee ("the Committee"), having considered a submisssion from the Landlord that all the works required by the Repairing Standard Enforcement Order (hereinafter referred to as "the RSEO") have been completed with the exception of the works to the kitchen fireplace which had been delayed with the Tenant's agreement to avoid the winter months and the Tenant having confirmed her agreement to such a delay, determined that the Landlord should be given an extension of the period allowed for the completion of the required work in terms of Section 25 (2) of the Housing (Scotland) Act 2006 (hereinafter referred to as "the Act")

### Background

- 1. Reference is made to the Determination of the Committee dated 17th October 2008 which decided that the Landlord had failed to comply with the duty imposed by Section 14(1)(b) of the Act and the RSEO made by the Committee which required the Landlord to carry out works as specified therein. The said works to be carried out and completed within a period of 28 days from the date of service of the Notice of the RSEO. Service of the Notice of the RSEO was effected on the Landlord on 30 October 2008.
- 2. In January 2009 the Tenant contacted the Private Rented Housing Panel by

telephone and indicated that she wished the works on the kitchen fireplace to be delayed as she did not wish to be without heating during the winter months. On 23 March 2009 a formal request was made to the Committee by the Landlord's agent to extend the timescale for completion of the works until 31 May 2009. The Landlord confirmed that all works detailed in the RSEO with the exception of the works to the kitchen fireplace had been completed. The Tenant confirmed her agreement to the variation.

3. The Committee, mindful of Sections 25(2) and (3) of the Act, considered that it would be appropriate to give the Landlord an extension of the period required to complete the works detailed in the RSEO and issued a variation of the RSEO in terms of section 25(1)(a) of the Act. The variation provides for the works in terms of the RSEO to be completed by 31 May 2009. The members of the Committee were unanimous in their decision.

The period allowed for the completion of the work required by the order is extended until 31 May 2009.

A landlord or a tenant aggrieved by this decision of the Private Rented Housing Committee may appeal to the Sheriff by summary application within 21 days of being

#### notified of that decision.

Where such an appeal is made, the effect of the variation is suspended until the appeal is abandoned or finally determined, and where the appeal is abandoned or finally determined by confirming the decision, the variation will be treated as having effect from the day on which the appeal is abandoned or so determined.
